

**TAYLOR HIGH SCHOOL ATHLETIC BOOSTER CLUB (“THSABC”)  
2010 RAFFLE RULES**

1. **PARTICIPATION.** From 5:30 p.m. on August 30, 2010 through approximately 5:00 p.m. on October 30, 2010, (“Entry Period”), participants may enter the THSABC 2010 Raffle (the “Raffle”) by purchasing a raffle ticket from an authorized representative or agent of THSABC (the “Sponsor”) for \$10.00 (Ten dollars), payable to THSABC, and completing and submitting to a THSABC representative the registration form on the removable ticket stub which will include name, complete address, city, state, zip code, and telephone number (the “Raffle Tickets”). By purchasing a Raffle Ticket, each participant acknowledges that such participant has read, understands and agrees to these Official Rules.

2. **SPONSOR.** The Raffle is sponsored by THSABC, a Texas charitable, non-profit organization under Section 501(c)(3) of the Internal Revenue Code. The Raffle will be judged by Sponsor's board of directors. All decisions of the judges are final.

3. **OFFICIAL DRAWINGS/DETERMINATION OF WINNER.** The official drawing will take place on October 30, 2009. It is intended to hold the drawing during the halftime of the James E. Taylor High School Varsity football game at Rhodes Stadium in Katy, Texas at approximately 1:30 p.m. The timing and venue are subject to change without notice at the sole discretion the THSABC Board of Directors. Five (5) random drawings will be conducted from among all eligible entries received. A Raffle Ticket may only win once. Odds of winning depend upon the number of eligible entries received, not to exceed 10,000 tickets sold. Participants do not need to be present at the drawing in order to win. If the winner is not present at the drawing, the winner will be notified by telephone, mail, and/or email. Any attempt to deliberately damage the content or operation of this Raffle is unlawful and subject to legal action by Sponsor or its agents.

4. **CONDITIONS.** A participant may only enter the Raffle via the ticket purchasing methods as described above. Incomplete entries are void. By entering, participants acknowledge compliance with these official rules including all eligibility requirements. All entries become the property of Sponsor and will not be returned. Neither Sponsor nor advertising and promotion agencies are responsible for incorrect or inaccurate transcription of entry information, or any other error or malfunction, or late, lost, illegible or misdirected entries. Entry materials that have been tampered with or altered are void. No copies, facsimiles or reproductions of entries will be accepted. In order to receive a prize, a winner may be required to sign an official waiver form provided by THSABC. Participants agree to be bound by the decisions of THSABC regarding disputes, conflicting claims or ambiguities concerning the rules.

5. **PRIZES.** There will be five (5) prizes awarded which are listed below with its approximate retail value.

2. 42” Flat Screen LCD HDTV (\$1,000)
3. Laptop Computer (\$800)
4. Laptop Computer (\$800)
5. XBox 360 (\$300)

Valuation of the prizes may be reported for tax purposes as required by law, and each winner is solely responsible for reporting and paying any and all applicable taxes and fees related to the prize and paying any expenses associated with receiving any prize. Valuation of the prizes are based upon good faith estimates by Sponsor as of the first date of the Entry Period. The Sponsor assumes

no responsibility for changes in market conditions that may impact the value of a prize, and there is no guaranty that a winner will be able to sell any prize for the estimated value or that the Internal Revenue Service, or its counterpart in any state's jurisdiction, will accept the value of any prizes for purposes of determining any tax that may be due by the winners.

6. **ELIGIBILITY.** The Raffle is open to legal residents of the State of Texas, United States, who are 18 years of age or older as of August 30, 2010. The Raffle is void where prohibited.

8. **TAXES AND FEES.** All applicable federal, state and local taxes, assessments, title and registration fees, insurance, and like charges associated with winning, possession or change of ownership of a prize in the Raffle will be the sole responsibility of the each winner of the prizes. Each winner shall be provided a 1099 form for income tax purposes. Consult a tax advisor to determine if the purchase of a Raffle Ticket may be deductible for income tax purposes.

9. **LIMITATIONS ON LIABILITY AND DISCLAIMERS.** Sponsor, its board members and its agents will not be responsible for or liable to the prize winner, winner's family or estate for any submissions of entries that are lost, late, illegible, damaged, incomplete, or incorrect. Sponsor can, at any time it chooses, without recourse, decide to terminate or modify the Raffle if the integrity of the Raffle appears to be compromised. Decisions of the judges related to the winner, interpretation of official rules, and other matters related to this Raffle are final. **SPONSOR MAKES NO WARRANTY OF ANY NATURE WITH RESPECT TO THE RAFFLE OR THE PRIZES, WHETHER IN RESPECT OF FITNESS FOR A PARTICULAR PURPOSE, SATISFACTORY QUALITY OR OTHERWISE. ENTRANTS ACKNOWLEDGE THAT, EXCEPT AS SPECIFICALLY SET FORTH HEREIN, SPONSOR HAS NOT MADE AND DISCLAIMS ALL LIABILITY FOR ANY WARRANTY, REPRESENTATION OR GUARANTEE, EXPRESS OR IMPLIED, IN FACT OR IN LAW, RELATED TO THE RAFFLE OR THE PRIZES. ALL ENTRANTS, BY ENTERING, AGREE TO BE BOUND BY THESE OFFICIAL RULES. BY ACCEPTING THE PRIZE, WINNER AGREES TO RELEASE SPONSOR, ITS TRUSTEES, EMPLOYEES, OFFICERS OR AGENTS, FROM ANY AND ALL LIABILITY, LOSS OR PERSONAL OR PROPERTY DAMAGES ARISING DIRECTLY OR INDIRECTLY OUT OF, OR IN CONNECTION WITH, THE AWARDING, RECEIPT, ACCEPTING, USING OR MISUSING OF THE PRIZE OR PARTICIPATION IN ANY PRIZE-RELATED ACTIVITIES.**

10. **GOVERNING LAW.** This Raffle is subject to all applicable federal, state and local laws. **THIS RAFFLE IS VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

11. **GENERAL.** The winner consents to the use of his/her name, biographical information, photographs and/or likeness for advertising and publicity purposes without additional compensation, except where prohibited. Sponsor reserves the right to verify eligibility qualifications of the winner.
